Permission Form for Youth who are Minors

The Pennsylvania Youth Action Conference, a program of the Pennsylvania Youth Congress Foundation (PYC), welcomes youth of all ages. The conference will take place at the Capital Area School for the Arts from April 13, 2018 at 7:00pm through April 15, 2018 at 1:00pm. This is a conference planned by and for youth from high school, college, and local communities across Pennsylvania.

PYC staff will create a safe and supportive environment for youth attending the conference who are under the age of 18. Specific resources will be given to minors attending the conference to ensure a safe and meaningful experience. Minors attending the conference will be coordinated on regular basis. However, PYC does not provide full time supervision for youth under 18 years old attending the conference. Parents or guardians sometimes share a hotel room with their child or other times pick up and drop off their child each day to the conference. As a youth conference, the conference space is dedicated to youth participants and not adults.

The following form must be completed by a parent or legal guardian and provided to PYC no later than the point of checking in for registration during the conference in order for a participant who is under the age of 18 to attend. Youth who are under 18 years old who arrive at the conference without this permission form completed will not be able to attend.

In the event of an emergency, PYC representatives are authorized to engage a licensed healthcare professional to render medical services which may, in the discretion of a doctor, be necessary; PYC representatives are also authorized to take participants to the hospital if necessary and participant agrees to pay all doctor, hospital and related bills.

I hereby grant permission by PYC the irrevocable, unconditional, and unrestricted right to photograph, record, videotape, and/or interview participant and to use, publish, broadcast, and publicly display participant's voice, likeness, or biographical information from official conference activities.
